| Can Harpenden Building Society change the interest rate?                       | Yes, we have the right to vary the rate of interest. | How do I open and manage my account?   | <p>You must be at least 18 years old and a UK resident and hold a valid national insurance number to open a Online Single Access ISA. You may only hold one Online Single Access ISA with us.</p> <p>This account can be opened on Harpenden Online via our website <a href="http://www.harpendenbs.co.uk">www.harpendenbs.co.uk</a>.</p> <p>Minimum balance: £1</p> <p>Maximum balance: £250,000</p> <p>Maximum yearly deposit limit is the current HMRC tax year allowance.</p> <p>Please note that you must fund the account with the minimum balance of £1 within 30 days of account opening, otherwise your application may be cancelled.</p> <p>If you have an existing Cash ISA with the Society, this can be transferred to this account without affecting your annual allowance.</p> <p>Please follow the guidance in our 'Identification Requirements' document available in branch and <a href="#">online</a>.</p> <p>We accept full and partial ISA transfers from both previous and current tax years into this account.</p> <p>This account can only be managed online (Subject to the <a href="#">terms and conditions of Harpenden Online</a>).</p> <p>Deposits can be made by bank transfer only.</p> |                     |
| Can I withdraw money?  | <p>Yes, you do not have to give notice to make a withdrawal or close your account.</p> <p>If you do make a withdrawal, the amount taken out cannot be replaced and will still count towards your annual ISA allowance (for that tax year). By taking money out of your Online Single Access ISA, you're also giving up the tax-free benefits on the amount taken out. This means you might need to pay tax on any future interest you earn on that amount.</p> <p>You will not be permitted to reduce the balance in your account to less than the minimum balance, unless you are closing the account.</p> <p>Withdrawals can only be made to a nominated bank account by faster payment via Harpenden Online which allows a maximum of £50,000 per day. There is not access to cash or requests for cheques with this account. Requests for withdrawals must be submitted through Harpenden Online by 3.00pm.</p> <p>Payment requests after this time will be processed the following working day.</p>   |                     |
